MEMBERS ARE RESPONSIBLE FOR THE BEHAVIOR OF THEIR CHILDREN AND ANY GUESTS. IF THERE IS UNACCEPTABLE BEHAVIOR, THE OFFENDER WILL BE SPOKEN TO BY THE GUARD. IF THE BEHAVIOR DOESN'T IMPROVE, THE OFFENDER WILL BE ASKED TO LEAVE THE POOL AREA FOR THE DAY. ONGOING BAD BEHAVIOR CAN RESULT IN FORFEITING YOUR POOL MEMBERSHIP.
