Members can bring up to five guests a day at a cost of \$5 per guest. The member must be with the guest.

Note: children under 10 years old must be accompanied by a person over 15 years old.

Note: As a resident pool member, you will also receive a complimentary pass to the tennis courts which are also open to resident and non-resident members only at this time.

MEMBERS ARE RESPONSIBLE FOR THE BEHAVIOR OF THEIR CHILDREN AND ANY GUESTS. IF THERE IS UNACCEPTABLE BEHAVIOR THE OFFENDER WILL BE SPOKEN TO BY THE GUARD. IF THE BEHAVIOR DOESN'T IMPROVE THE OFFENDER WILL BE ASKED TO LEAVE THE POOL AREA FOR THE DAY. ONGOING BAD BEHAVIOR CAN RESULT IN FORFEITING YOUR POOL MEMBERSHIP.
