IF THE BEHAVIOR DOESN'T IMPROVE, THE OFFENDER WILL BE ASKED TO LEAVE THE POOL AREA FOR THE DAY. ONGOING BAD BEHAVIOR CAN RESULT IN FORFOEITING YOUR POOL MEMBERSHIP.
